### **Janine Ellison**

**Senior Advisor to the U.S.-Russia Bilateral Presidential Commission, Department of State**

Janine Ellison is Senior Advisor to the U.S.-Russia Bilateral Presidential Commission. Previously, she served as Senior Director and Director for Russia at the National Security Council. During the July 2009 Summit in Moscow, Ms. Ellison was the Acting Director of the Office of Russian Affairs at the Department of State. From 2002 to 2004, Ms. Ellison worked as Political Officer in the U.S. Embassy in Moscow and at the United States Mission to the United Nations in New York. She also worked as a research analyst in the State Department's Bureau of Intelligence and Research. In addition, Ms. Ellison was a National Security Education Program fellow at Irkutsk State Polytechnic University in Irkutsk, Russia.

### **The Honorable Robert C. McFarlane**

**Chairman, McFarlane Associates Inc, Former National Security Advisor under President Ronald Ragan**

Mr. McFarlane serves Chairman of McFarlane Associates Inc., a consulting firm focused on advancing technologies in the national security and homeland security domains. He is a co-founder (with Dr. Henry Kissinger) and Vice Chair of the America-China Society, and is a Director of the Washington Institute for Near East Policy.

He entered the private sector following a distinguished career in government, including serving as President Reagan's National Security Advisor where he was responsible for the development of U.S. foreign and defense policy. Mr. McFarlane is best remembered as the architect of the comprehensive set of U.S. policies – including most notably the Strategic Defense Initiative (or Star Wars).

Following his retirement from government Mr. McFarlane founded his own company, Global Energy Investors (GEL), a developer of energy infrastructure projects in Asia and South America. In 2000, he co-founded and chaired Energy and Communications Solutions LLC, which focused on projects in the former Soviet Union, Turkey, Eastern Europe and other emerging market countries.

### **Michael McFaul**

**Special Assistant to the President and Senior Director for Russian and Central Asian Affairs, National Security Council**

Michael McFaul is Special Assistant to the President and Senior Director for Russian and Central Asian Affairs at the National Security Council. McFaul was an advisor on Russia and Eurasia to Barack Obama during the presidential campaign and the transition. He is a leading expert on U.S. foreign policy, U.S.-Russian relations, and political and economic reform in the CIS.

Previously, he was Deputy Director of Stanford University's Freeman Spogli Institute for International Studies, Director of its Center on Democracy, Development, and the Rule of Law, and Senior Fellow at the Hoover Institution, where he co-directed the Iran Democracy Project. He was also a non-resident Senior Associate at the Carnegie Endowment for International Peace.

He served on the Board of Directors of the Eurasia Foundation, the Firebird Fund, Freedom House, the International Forum for Democratic Studies of the National Endowment for Democracy, and the International Research and Exchanges Board (IREX).

He is the author of many monographs and articles on Russia, Ukraine, and the CIS, focusing on political developments in the region

**Ambassador James F. Collins**  
**Director of the Russia and Eurasia Program, Carnegie Endowment for International Peace**

Ambassador James Collins was appointed the Director of the Russia and Eurasia Program at the Carnegie Endowment in January 2007. Prior to that, he served as Senior Advisor to the public law and policy practice group at Akin Gump Strauss Hauer & Feld, LLP. He was the U.S. Ambassador to the Russian Federation from 1997 to 2001.

James Collins served as Ambassador-at-Large and Special Advisor to the Secretary of State for the New Independent States and as deputy chief of mission and charge d'affaires at the American Embassy, Moscow from 1990 to 1993. He also held positions in the American Embassy in Amman, Jordan, and the Consulate General in Izmir, Turkey.

Ambassador Collins is the recipient of the Secretary of State's Award for Distinguished Service; the Department of State's Distinguished Honor Award; the Secretary of State's Award for Career Achievement; the Department of Defense Medal for Distinguished Public Service; and the NASA Medal for Distinguished Service.

Ambassador Collins is Co-Chair of the new U.S.-Russia Foundation for Economic Advancement and the Rule of Law (the U.S.-Russia Foundation) and has served as a member of the board of the U.S.-Russia Business Council, the American Academy of Diplomacy, the Open World Leadership Center, and the American Councils for International Education.

**Ambassador John M. O'Keefe**

**Executive Director, Open World Leadership Center, Library of Congress**

John O'Keefe is Executive Director of the Open Word Leadership Center at the Library of Congress. Before assuming his position in 2007, former Ambassador O'Keefe had a long and distinguished career with the U.S. Department of State. He was Acting Director General and then Deputy Director of the Foreign Service Institute from February 2006 to August 2007. Before that, he served as Deputy Assistant Secretary in the Office of the Director General, Bureau of Human Resources, and head of the Office of Career Development and Assignments from 2003 to 2006. Before serving as U.S. Ambassador to the Kyrgyz Republic from 2000 to 2003, O'Keefe served in many high-profile positions.

**The Honorable Toby T. Gati**

**Senior International Advisor, Akin Gump Strauss Hauer & Feld LLP**

Toby T. Gati is Senior International Advisor at Akin Gump Strauss Hauer & Feld LLP, where she focuses on Russia, Central Europe, the Newly Independent States, and various politically sensitive regions of the world, as well as the workings of international political and economic institutions.

Mrs. Gati served as Special Assistant to the President and Senior Director for Russia, Ukraine and the Eurasian States at the National Security Council in the White House in 1993 and then as Assistant Secretary of State for Intelligence and Research (INR) until May 1997. Before joining government, Mrs. Gati was Senior Vice President for Policy Studies at the United Nations Association of the United States of America (UNA-USA), where she worked for over 20 years.

She previously worked as Chief Editor of Profile magazine, Deputy Editor-in-Chief of the Moskovskie Novosti newspaper, Chief of the RIA Novosti Bureau in Great Britain (2004-2006), and the head of Izvestia's political department (2000-2004).

### **Dorothy Dwoskin**

#### **Senior Director of Global Trade Policy and Strategy, Microsoft**

Dorothy Dwoskin has been the Senior Director of Global Trade Policy and Strategy for Microsoft Corporation since 2007. She is also a member of Microsoft's Federal Government team in Washington DC. Ms. Dwoskin is responsible for leading the company's policy efforts to promote open markets and fair trade in software and services, collaborating with government agencies, Congress, international organizations, and foreign governments.

Ms. Dwoskin previously served as the Assistant U.S. Trade Representative for the World Trade Organization (WTO) and Multilateral Affairs at the Office of the U.S. Trade Representative (USTR). In that position, she was responsible for trade negotiations and policy matters before the WTO. Ms. Dwoskin also was the senior career official responsible for the Doha Development Agenda (DDA) negotiations and the Uruguay Round of GATT negotiations. She served as lead U.S. negotiator on a variety of trade policy issues in the WTO, APEC and OECD, including the Information Technology Agreement (ITA). She successfully negotiated WTO market access agreements and multilateral accession negotiations with Russia and the Ukraine, and concluded membership negotiations for the accession of Vietnam and Saudi Arabia to the WTO, among others.

From 1985 to 1988, Ms. Dwoskin served in USTR's Geneva office, which represented the United States to the General Agreement on Tariffs and Trade (GATT), where she was the officer in charge of trade in services and development-related issues.

### **Shelby Coffey III**

#### **Senior Fellow, Freedom Forum**

Shelby Coffey is a Senior Fellow at the Freedom Forum and a Trustee of the Newseum. He was President of CNN Business News and CNNfn, the financial network, from 1999 to 2001. Previously, he was Executive Vice President of ABC News. Mr. Coffey worked as editor and Executive Vice President of the Los Angeles Times from 1989 to 1997 and

was named editor of the year by the National Press Foundation in 1995. Prior to joining the Times, he was Senior Vice President and editor of the *Dallas Times Herald*, and the editor of *U.S. News & World Report*. Mr. Coffey began his journalism career at The *Washington Post* as a sports reporter and held a variety of editorial positions there over the next 17 years.

**Thomas Rhodenbaugh** is the Program Coordinator and Consultant-Supporters of Civil Society in Russia (SCSR). He provides program planning, development and fundraising support to non-governmental organizations in the U.S. and abroad. Previously he served as Director of U.S. and Eastern Caribbean programs for Save the Children and Christian Children's Fund and as President of Designs for Rural Action.

**E. Terrence Jones** is Professor of Political Science and Public Policy Administration at the University of Missouri-St. Louis. His specialties include metropolitan governance, voting behavior, and public opinion. He is the author of numerous books and articles addressing research methods, governmental reform in the St. Louis region, metropolitan politics and regional trends. He can often be heard as a commentator on local public radio and has served as a consultant for numerous public, private and non-profit concerns.

**Julianne Stone** is the Director of the Local Government Partnership, a collaborative of the East-West Gateway Council of Governments and University of Missouri, to provide training, technical assistance, outreach and information to local government officials. She has also worked for the Missouri Department of Natural Resources and as Policy Assistant to the Mayor of the City of St. Louis City.

**Jerol Enoch** is the Coordinator of International Programs for the Center for International Studies at the University of Missouri-St. Louis. He serves as the coordinator for numerous international programs sponsored by the University. He is currently a PhD student in the school of Education, focusing on teaching and learning processes.

**Russ Signorino** is the Executive Director of Gateway EITC Community Coalition. He previously served at the Vice President of the United Way of Greater St. Louis. Russ also has extensive experience in workforce development as a Workforce Coordinator with the St. Louis County Economic Council and as a Labor Market Analyst with the State of Missouri.

**Maggie Hales** is the Deputy Executive Director of the East-West Gateway Council of Governments (EWG). EWG is the regional planning organization serving eight counties. A governmental organization headed by a board of directors comprised of the chief elected officials of the region, EWG handles transportation and other regional projects. Hales has also served as the Deputy Director of the St. Louis Area Regional Response System and as Legal Counsel to the May Company.

**Steve Johnson** is Senior Vice President for the Regional Chamber and Growth Association (RCGA), the region's chamber of commerce. He joined RCGA in 2004. He has held similar positions in Kansas City (Missouri-Kansas) and Mobile (Alabama).

**Tom Irwin** is Executive Director for Civic Progress, the organization representing the largest corporations in the St. Louis region. His previous positions include Executive Director of Metro (the regional transit agency) and Executive Director of the Missouri Gaming Commission.

**Christine Chadwick** is the founding Executive Director (since 1996) of FOCUS St. Louis, a non-profit organization that works to strengthen the St. Louis region by developing leadership, influencing policy and promoting community connections. She also directs the Leadership St. Louis and Experience St. Louis programs and serves as lead consultant/project manager on many customized programs for clients such as Pfizer, Commerce Bank, Monsanto, Parkway Schools, and others.

**Lawrence Mooney** serves as a Judge on the Missouri Court of Appeals, Eastern District. He was appointed in 1998 to the Court of Appeals and retained in office by election in 2000 for a 12-year term expiring December 31, 2012. He served as Chief Judge from 2002-2003. Before joining the bench, he served as executive assistant to the St. Louis County Executive, prior to which he was a prosecuting attorney for St. Louis County.
